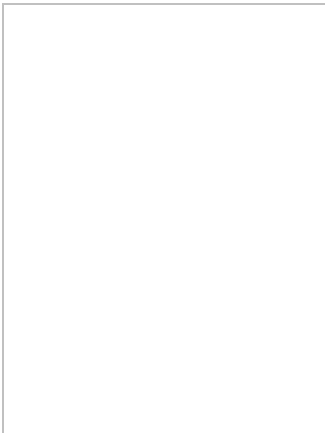

For regulatory and data protection purposes, we upgraded to a user-centered MyATCB operational platform, updated the website, and digitalized all records and files for easier access.

Reminder: Renewal and Recertification

The July 1, 2022, to June 30, 2023 credential year had started. If you have not already done so, the ATCB affords a 30-day grace period through the month of July, there is a \$30 late fee.

If you are board-certified and your certification cycle ends July 1, 2022, don't forget to also complete the recertification of your board certification!

Remember, ATR-BC maintenance requires two processes: the ATR annual renewal and the Board Certification five-year recertification. There are different applications and fees for each.

**Any credential not renewed by July 31 will go inactive.
Any board certification whose cycle ends July 1, 2022 that is
not recertified by July 30 will no longer be valid.**

While it's easy to confuse the meaning of the renewal of the term vs. recertification, they are two distinct processes that require attention in different ways.

To become an ATR, an individual must meet the registration standards, which outline the education and post-education requirements.
